It was determined that Mr. Schlinder is not entitled to service credit for the period of time during which he was out on approved unpaid leave of absence.
- Mr. Timmony referenced an email correspondence submitted to the Pension Board by Mr. Philo dated August 2011 in which Mr. Philo states "upgrade" pay is NOT to be included in FAC, however at this Board meeting Mr. Philo made a verbal statement that after a meeting with Chair Hill, he now understands and believe that "upgrade" pay SHOULD be included in FAC.
